




Located on the fringe of Melksham Town Centre, the site benefits from various access points, suitable for large HGVs and commercial vehicles. The main access to the site is off Bath Road, which is situated adjacent to Lidl supermarket.

Melksham is a popular and expanding town located in mid Wiltshire on the strategic A350 that links Junction 17 of the M4 motorway (11 miles distant) with the south coast ports.
